## OBJECTIVES AND INVESTMENT POLICY

The Fund aims to track the returns of the FTSE All Share Index, an index of over 500 UK shares. Any returns will be a mixture of income and growth. The actual returns may be lower than that of the index as a result of the effect of charges.

The Fund invests in all the shares and in the same proportion as the Index, except where prevented by the UK Fund rules, to meet the aim of mirroring the performance of the index. Investment in shares will be limited to those included in the index. Derivatives (financial instruments whose value is linked to the expected future price movements of the index) may be used in the short term to efficiently manage cash flows. Investors will normally be fully exposed to the index with very little counterparty exposure.

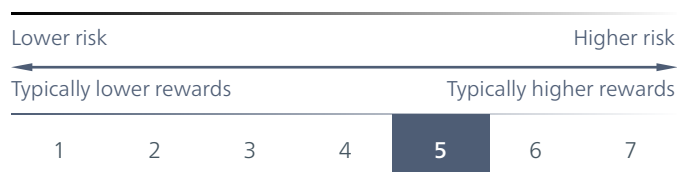
You can buy and sell shares on any London business day.
